## STRATEGIC PLANNING: ADVANCEMENTS & ACCOMPLISHMENTS

The IDEC Board of Directors developed the Strategic Plan in 2005. This document guides us in our actions and decisions from year to year. The plan is a living document that is not only nimble enough to respond to unexpected situations and opportunities, but also stable enough to direct the organizations path forward. Below is a list of accomplishments during 2008-2009.

#### **ADVANCEMENT OF INTERIOR DESIGN EDUCATION**

IDEC is fortunate to have new visionary partners from the industry who are embracing the strategic goals of IDEC. Of note is the work of Kimball who sponsored the Kimball Office Working Group in 2007 to examine the lack of qualified individuals to fill vacant interior design educator positions. Teknion joined the effort in 2009 and assisted in the dissemination of materials in major markets throughout the US and Canada. Their generosity is helping us tackle this issue in a way that we could not have done alone. Each of the following accomplishments/advancements supports the group's recommendations delivered to the IDEC Board in 2008.

- Paper researching the necessary credentials for several types of educational positions to assist professionals in understanding the many ways in which they can contribute to education (in process).
- Creation and dissemination of the "Believe" brochure. Spearheaded by Georgy Oliveri and supported by Kimball and Teknion
- IDEC Academy receives IDEC Strategic Initiative Grants and support from ASID to develop courses to assist practitioners and junior faculty in their new role as educators.
- Presentations of "How to Become an Educator" at NeoCon and IIDEX by Eric Weidegreen, Jane Kucko, Jill Pable.
- Identification of graduate programs for place-bound practitioners. (Report submitted by Susan Ray-Degges, Linda Nussbaumer, and Carolyn Sockwell of the Distance Learning Network; funded by IDEC Strategic Initiatives Grant)
- IDEC Strategic Initiatives Grants funds "Development of National Junior Interior Design Certificate of Achievement for High School Students (IDCA): Phase I" submitted by Stephanie Clemons. The grant seeks to assist in the writing of the exam test to assure a more accurate reflection of interior design.

#### **ADVANCEMENT OF SCHOLARSHIP**

The advancement of scholarship that supports the discipline of interior design is an important aspect of our organization. Currently, our two major vehicles for the development and dissemination of scholarship are through our Proceedings and the *Journal of Interior Design*. IDEC also supports scholarship through two grant opportunities: Special Projects Grants (IDEC Foundation), Fairchild Topical Issues Grant.

- Journal of Interior Design goes international with its new partner Wiley/Blackwell. The journal went completely
  online in 2008. Submissions from authors outside of North American have come from Japan, Belgium, and the UK.
- Scholarship Dissemination Task force charged to Evaluate opportunities to disseminate conference presentations to a larger audience.
- Proceedings Task Force charged to analyze the effectiveness and relevance of current Proceedings and to make suggestions for improvement.
- 2009 IDEC Special Projects Grant Recipient: "Way Finding in Healthcare Facilities for the Senior Population" by Seunghee Lee, Purdue University.
- 2009 IDEC Strategic Initiatives Grant Recipients: IDEC Academy
- 2009 Fairchild Topical Issues Grant Recipient: "Indoor Air Quality of Interior Materials on Occupants' Well-being" by Nancy Kwallek, University of Texas at Austin

## STRATEGIC PLANNING: ADVANCEMENTS & ACCOMPLISHMENTS

#### **ADVANCEMENT OF IDEC**

Over the past few years, IDEC's stature amongst its peer organizations has grown substantially thanks to the efforts of previous Presidents. IDEC is viewed as a valuable member at the table whose advice is sought on educational and professional issues. Presidents continue to participate in Issue Forums meetings and phone conversations, and play an active role on various committees. President Turpin represented IDEC at the 2008 ACSA Administrator's Conference in Savannah for a panel discussion on the Future of Design. President-elect Jill Pable attended the NCIDQ national conference in Kansas City and provided much needed information on a number of important topics. IDEC was also a valued participant in the development of the National Academy of Environmental Design. Julie Stewart-Pollock represented IDEC as they formed the NAED's mission and purpose, Articles of Incorporation, and By-Laws. While IDEC continues to lead through these important interactions, other internal accomplishments were equally valuable in advancing the organization.

- Staff size increased in response to IDEC's growth; an additional .5 FTE dedicated to marketing and communications (Andrea Cowan) and .25 for a designated conference planner (Patty Warren). IDEC now has 2.5 FTE
- Membership survey completed with a summary of results and an executive summary accepted by the board and posted to the website.
- Membership categories were redefined, approved by the membership, and accepted by the board for acceptance to IDEC's Policy and Procedures.
- Addition of a Director of Communications to the IDEC Board of Directors. Lisa Tucker filled in as the interim until
  election of 2010 officers.
- Website Review Task Force charged to evaluate the effectiveness of the IDEC website. Recommendations addressing graphics, images, content, operation and navigability have been received, and an implementation schedule is in the works.
- Regional Chairs completed the first draft of a Policy and Procedures document to assist them in their numerous tasks.
- First IDEC Leadership Orientation held in St. Louis to better prepare volunteers for service in leadership positions.
- Two new networks developed by IDEC members met for the first time at the St. Louis conference: Legislative network and Future Faculty network.

#### **ADVANCEMENT OF MEMBERSHIP**

The IDEC Board often finds it difficult, at times, to assign our goals and accomplishments to just one category. Many of the accomplishments and opportunities listed in the first three strategic directions also benefit the individual member. The Leadership Orientation serves both IDEC and the member, the grants advance scholarship as well as the individual, the Website Task Force is intended to improve our communication with the member as well as enhance the resources available to the member. Much of what we do is intentionally geared toward the advancement of the member because that is why we are here. Below are some additional accomplishments made over the last year.

- Adoption of "The Value of Including Creative Endeavors in the Tenure and Promotion Process." Task force chaired by Shari Park-Gates.
- Opportunities to disseminate peer-reviewed scholarship (regional and national conferences)
- Workshops to enhance teaching and/or scholarship

## STATEMENT OF FINANCIAL POSITION

#### REPORT SUBMITTED BY LYNN CHALMERS, SECRETARY/TREASURER


The September 30th 2009 Year End Financial Report is revealing that the IDEC financial picture is strong. Year end assets are at \$535,651 due to strategic and conservative decision making, as well as good management. It is notable that savings (\$373,212) currently equals approximately 87% of estimated 2009-2010 budgeted operating expenses. Investments reflect \$25,000 deposit with the Polsky Fund (partnership with the IDEC Foundation) with the remaining \$55,861 being invested in Mutual Funds with Smith Barney. In spite of planning a deficit budget of more than \$38,000, an overall net gain of more than \$16,000 was achieved. This net revenue is applied to the organizations savings assuring that a "Rainy Day Fund" continues to grow strong.

Contributing factors to the strength of IDEC's Finances are plentiful. In spite of a weak economy and ominous environmental threats, educators are proving with their finances that IDEC is a worthy professional experience. Strong net revenues at the annual conference in St.Louis continue to allow reasonable conference rates and membership dues to prevail. Beside the generous support of our donors and partners, IDEC contributed \$6,475 to Sustaining Interior Design Education, \$5,000 to other strategic initiatives and \$10,000 to updating the Body of Knowledge in partnership with the Issues Forum.

## Sustaining Interior Design Education (SIDE) Work Group

REPORT SUBMITTED BY JOY H. DOHR, COORDINATOR

The Kimball Office Work Group was challenged to develop recommendations and strategies to increase the pool of qualified interior design educators. A final report and proposed plan was delivered to the IDEC Board and Issues Forum partners in November 2008. The full report can be found on the IDEC website, but below are the two main strategic goals and the list of recommendations.

STRATEGIC GOAL 1 Promote interior design education by developing ways for practitioners to reach students via classroom teaching and other learning opportunities.

**RECOMMENDATION 1** We recommend that credentials for several types of interior design education positions be identified and developed via an IDEC White Paper. The positions we suggest and qualifications or required credentials to be developed include:

- the practitioner-educator to teach in part-time interior design education positions
- the practitioner-educator to teach in full-time, non-tenure track interior design education positions
- the educator to teach in full-time, tenure track interior design education positions

**RECOMMENDATION 2** We recommend that course(s), methods, and materials be developed to teach ID practitioner-educators ways to contribute to scholarship (both research and creative performance).

**RECOMMENDATION 3** We recommend existing graduate education programs and courses be identified, developed as an information source, and then be disseminated and promoted to practitioners to create awareness among practitioners of advanced interior design education opportunities, i.e., types of degrees, value of a graduate degree, types of programs, resources required and available, etc.

**RECOMMENDATION 4** We recommend five strategies to create and advance relationships, opportunities, and understanding of needs among students, practitioners, and educators over the next five years.

STRATEGIC GOAL 2 Develop a communication plan for practitioners and all stakeholders to learn about the lack of qualified interior design educators, careers in higher education, and graduate education opportunities. This communication plan should address various levels of awareness, interest, and actions. It should also cover multiple visual and verbal venues including on-line, print, presentations, and dialogue

#### **RECOMMENDATION 5**

- We recommend that a communication plan be developed for stakeholders to learn about ID education as a career. This includes awareness of the current issue (crisis) and the potential solutions, and providing access to the solutions while promoting the value of education as a career.
- We recommend incentives be communicated by identifying the value and uniqueness that practitioners and educators each bring to the profession, the value of and incentives for graduate education, and potential funding pools for developing financial packages for new educators.
- We recommend the creation of venues for dialogue among stakeholders to create awareness, interest, and solutions to the issue. These include roundtables, workshops, collaborative partnerships, speaker's bureau, and on-going operations such Applied Brilliance Conference, large firm roundtable, student career days, etc.

At the writing of this report, work has begun on recommendations 1 and 2 as indicated above. In addition, the Believe brochure was completed (previewed at St. Louis conference) and is currently being distributed by Teknion and Kimball associates in the top 20 markets across the US and Canada. The IDEA-Line is working well and we've assisted those who have contacted us from Canada and from Alaska to Florida and New York to California. We are sad to add that our colleague and IDEA-Line adviser in Winnipeg, Hope McKenzie, died this past May. Hope was an interior designer, a past board member of IDC and FIDER (now CIDA), and occasional adjunct instructor at the University of Manitoba.

The work is only made possible by the generous support of Kimball Office and its corporate interest in sustaining Interior Design Education in the 21st-century.

#### REPORT SUBMITTED BY STEPHANIE A. CLEMONS, CHAIR

The *Journal of Interior Design* has experienced a landmark year. The first electronic issue with our new partners, Wiley/Blackwell, was launched in June 2008. All 34 volumes are now available online. As of March 2009, over 4,400 articles were downloaded and the publication experienced a 6% increase in institutional full rate subscriptions in just the first three months. The Wiley/Blackwell representative noted this as "tremendous growth." The increased visibility of JID is also evident in the growth of international submissions from Belgium, Canada, Japan, United Arab Emirates, and the United Kingdom. ASID has agreed to publish monthly JID abstracts in their newly reformatted/designed ICON. Due to the increased visibility, the *Journal of Interior Design* is making plans to move to a quarterly publication schedule in 2010.

The Journal is currently undergoing a transition between editors. We are delighted to welcome Meg Portillo, Ph.D. from the University of Florida as Editor-in-Chief and Tiiu Poldma from the University of Montreal as Associate Editor. Both are exemplary scholars and professionals who will be able to competently guide us through the next phase of journal publication and beyond.

The JID Board continues to offer workshops for both reviewers and writers at the IDEC conference, although some may be moving to webinars in the future in order to improve access.

The size of the JID Board has downsized from five to three (not including the editor, associate editor and liaison) due to the new association with Wiley/Blackwell.

The IDEC Foundation was pleased to award eight Graduate Student Scholarships (\$1,000 each) for the 2009 IDEC Annual Conference. In addition, the Foundation funded the IDEC Special Projects grant (\$4,000), the Carole Price Shanis Scholarship (\$3,000), and the JID History Symposium (\$3,300). The annual fundraiser at the 2009 IDEC Annual Conference received pledges in the amount of \$6,435 and the Foundation has initiated efforts toward applying for a challenge grant from the Norman & Elaine Polsky Family Supporting Foundation. The Fellows are spearheading several projects. The first, led by Josette Rabun, is the exploration of an interior design honor society and the selection of a hood color that would be worn by the interior design students at graduation. The Fellows have been working with Academic Cap and Gown, and bilberry was selected as the hooding color unique to the interior design profession. Buie Harwood is spearheading a history of the *Journal of Interior Design* with Stephanie Clemons and Dorothy Fowles.



## THE SPIRIT OF EXPLORATION: THE GATEWAY TO NEW FRONTIERS St. Louis, MO I March 25-28

The St. Louis conference was yet another memorable experience in the history that is IDEC. Inspired by the city of St. Louis, the conference theme—The Spirit of Exploration: The Gateway to New Frontiers— celebrated our roles as educators and researchers by recognizing our efforts to open up young minds in preparation for their future and create new knowledge in the discipline of interior design. We had excellent attendance with over 300 registrants.

The conference started with a spirited keynote address by Andrea Dawson Sheehan of Dawson Design Associates in Seattle. "Gen-Y—A Wake-Up Call: Facing the Harsh Realities of Working in a Design Firm" offered insightful observations of the attitudes of today's graduating students. A comical, yet practical discussion about the expectations and perceptions of Gen-Y, reminded us of the challenges of educating each new generation. What was even more impressive was Sheehan's boot camp—an excellent model of how practitioners can continue the education process for recent graduates.

Immediately following the keynote address, the membership had an opportunity to participate in the annual Fellows Forum. This year's Forum—entitled Four Futures—engaged the membership in a new format, fostering informative discussions on a controversial topic. "Interior Architecture" has become a topic of great debate over the last few years in North America and abroad. Some view it as a natural offspring of architecture and interior design; others see it as a potential threat to the existence of interior design. Each of the tables at the conference was given a potential future regarding the relationship between "interior design" and "interior architecture." The table addressed the pros and cons of that future and provided strategies to make that future possible. They could also create their own future. The Four Futures discussion yielded a great deal of information that will be disseminated to the membership.

As always, the four-day conference was packed with opportunities for professional development, networking, and simply getting in touch with old friends and making new ones. Attendees could choose from eight workshops ranging from manual sketching to a stimulating discussion regarding curricular opportunities between architecture and interior design programs. We had over 100 papers, posters, and presentations ranging from research, teaching forums, and creative scholarship. For those wanting some time off-site, tours of the Gateway Arch, Alberici Headquarters and downtown St. Louis were available.

Members of the Kimball Office Working Group (now known as the Sustaining Interior Design Education initiative) presented their recommendations on how we (the profession) might increase the ranks of Interior Design educators. See their report in this document for more details.

On Saturday evening, we celebrated our successes at the Annual Awards Banquet. Who could have foretold that the "San Francisco" cake would reappear after seven years? I am thankful that all I had to do was pass it to the next President. Congratulations, Jill!


